Did you know? Al systems can sometimes "hallucinate," generating false or nonsensical information that's completely made up. Usually, it's pretty close to the truth too. It's a reminder of the importance of careful Al fact checking and validation.

1. Introduction

This guide outlines the use of third-party or publicly available 'generative' AI tools, including platforms like ChatGPT, Google Gemini, DALL-E, Midjourney, MS Copilot and similar applications that simulate human intelligence to generate responses, create work outputs, or perform specific tasks.

For simplicity, we have broken this down into some simple dos and don'ts.



2. **Do:**

- ✓ **Explore AI:** Find, explore and discuss with colleagues the ways in which AI can help and be useful in your day-to-day activities.
- ✓ **Verify Al Outputs:** Always double-check the accuracy of Al-generated information, as it may contain errors or "hallucinations."
- ✓ Prioritise Ethics: Always consider the ethical impact when using AI tools. Be mindful that AI can sometimes reflect biases, leading to unfair results.
 Remember to use AI in a way that aligns with your companies' ethical values.
- ✓ Maintain Human Oversight: Use AI tools to assist, not replace, human judgement and creativity.
- ✓ Handle Data Cautiously: Treat all data input into AI tools as potentially public.
- ✓ Report Al Usage: Keep your management informed about your use of Al tools for task completion, footnote the use of Al on websites, or documents.
- ✓ Ensure Compliance: Make sure Al-generated responses comply with intellectual property, GDPR and privacy laws and align with other company policies.



3. **Don't:**

- Don't rely solely on AI algorithms for critical decisions without human intervention.
- × **Don't use AI tools for important decisions,** such as employment-related decisions, including recruitment, hiring, performance monitoring, and termination.
- Don't input company information including confidential or sensitive company information into AI tools which have not been authorised and secured by your cybersecurity team.
- x Don't upload personal details to non-approved or unsecured Al tools such as names, addresses, emails, payment info, likeness, individual data or photos. Instead, anonymize data or use random identifiers.
- x Don't claim Al-generated work as your own original creation, footnote the use of AI on websites, or documents.
- x Don't integrate any AI tool with internal Company software without first receiving specific documented permission from your seniors or management.
- × **Don't trust all Al tools.** To ensure information security, stick to Al tools approved by your company and refer to Why Settle Technology for when you need help and guidance.

Top Tip: Treat every shred of information you provide to a non-approved Al tool as if it could go viral on the Internet.
